AB 458 - Healthy Youth Act

Requires sex education taught in Wisconsin public schools to be medically accurate, age-appropriate and comprehensive. PPAWI supported this bill. (2010)

SB 460 - Expedited Partner Therapy

Reduces the rate of STDs by allowing providers to dispense a second dose of antibiotics for the partner of a patient being treated. PPAWI supported this bill. (2010)

AB 377 - Compassionate Care for Rape Victims

Requires hospitals to provide rape victims with information on and access to emergency contraception to prevent pregnancy after an assault. PPAWI supported the vote on adoption. (2007-08)

AB 710 - Abortion Ban

Bans certain abortion procedures that are safest in emergency situations and prevents doctors from using their medical judgment to protect the health of pregnant women. PPAWI opposed this bill. (2008)

SB 232 - Birth Control Protection Act

Protects women's access to birth control by requiring that pharmacists dispense safe, legal birth control at the pharmacy counter. PPAWI supported this bill. (2008)

State Budget

* This legislator voted for the State Budget. The State Budget contained four prevention first initiatives: Contraceptive Equity (requires insurance plans that cover prescription drugs to also cover prescription contraceptives); Prescription Protection (requires pharmacies to dispense birth control prescriptions); Colposcopy Funding (provides life-saving diagnosis and treatment of cervical cancer for low-income women); and Expansion of the Family Planning Waiver (provides family planning and preventive health care to low-income women and men). PPAWI supported the State Budget. (2009)
